<p><u><b>Property Management Fees</b></u></p> <p>* Oversight and administration of trust-owned real property, including rent administration, vendor and contractor coordination, lease and compliance review, maintenance supervision, expenditure approvals, reporting, and beneficiary communications. Services are performed in Trustee capacity and do not constitute licensed real estate brokerage services.</p> <p><u><b>Optional Percentage Fee:</b></u> At the Trustee’s discretion and with advance written disclosure, a monthly or percentage-based property management fee (typically 3%–6% of gross rents or other agreed metric) may be charged in lieu of hourly billing.</p>	<p>TBD</p>
